## <u>Sub: Outcome of the Board Meeting pursuant to the SEBI (Listing Obligations and Disclosure</u> <u>Requirements) Regulations, 2015</u>

Pursuant to the provisions of Regulation 30 and other applicable provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), we wish to inform you that the Board of Directors (the "Board") of the Company at their Meeting held today, i.e., August 01, 2024, considered and has *inter alia* approved the following:

# 1. <u>Convening of the 30<sup>th</sup> Annual General Meeting ("AGM")</u>

The 30<sup>th</sup> AGM of the Members of the Company will be held on Thursday, September 26, 2024, at 01:00 p.m. through Video-Conferencing/ Other Audio-Visual Means.

The proceedings of the AGM shall be deemed to be conducted at the Registered Office of the Company.

### 2. <u>Change in Directors and Key Managerial / Senior Managerial Personnel(s)</u>

The Board basis the recommendation of the Nomination & Remuneration Committee of the Company considered and approved the following:

a) Re-appointment of Dr. Anoop Kumar Mittal (DIN: 05177010) as an Independent Director of the Company for second tenure of 4 consecutive years w.e.f. June 16, 2025, subject to shareholders approval at the ensuing 30<sup>th</sup> AGM of the Company.

Dr. Mittal is not related to any Director of the Company and satisfies the criteria of independence prescribed under the Companies Act, 2013, and SEBI Listing Regulations, further, in accordance with the circular dated June 20, 2018, issued by the Stock Exchanges, it is hereby confirmed that Mr. Mittal is not debarred from holding the office of Director by virtue of any Order passed by SEBI or any other such authority.
