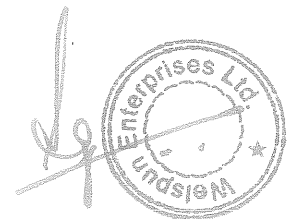
The Board of Directors of the Company at its meeting held on May 30, 2017 has interalia, transact the following business:
